SWIM SURVEY

This survey will be used to assess the level of assistance required for your child during swimming field trips. Please read carefully and check the box that applies to your child.

Swimming Ability:

Level 1: Clown Fish

- Members who are under the age of 10 and are unable to swim, or can swim only with one on one adult assistance.
- Will swim in the Wading Pool (a 0 – 3 ft wading pool) with an extremely high level of supervision and assistance.

Level 2: Sea Turtles

- Members who can swim or doggy paddle at a basic to moderate level, or is tall enough to stand in the shallow section of the pool (3 – 5 ft).
- Will swim in the shallow section of the pool (3 – 5 ft) with a high level of supervision.
- Will NOT be given consistent one on one attention. If your member requires one on one attention to swim, they should be put in Level 1: Clown Fish.

Level 3: Dolphins

- Members who can swim at a moderate level with little supervision.
- Will swim in the shallow and deep sections of the pool (3ft to diving depth) and will be permitted to use the diving board with a moderate level of supervision.
- Dolphins **will not** be permitted to attempt flips off of the diving board.

Level 4: Sharks

- Members who can swim at an advanced level with very little supervision.
- Will swim in the shallow and deep sections of the pool (3ft to diving depth) and will be permitted to use the diving board with a limited level of supervision.
- Sharks **will** be permitted to safely attempt flips off of the diving board.
